



TERMS AND CONDITIONS

The invitation price includes printed insert using black laser printing with matching envelope, materials and labour required to complete your selection. Printing in colour is an additional charge, price on application.

1. Payment terms

- 1.1. 60% deposit of total order is required prior to commencement of work
- 1.2. Remaining 40% is required prior to shipment or collection of order
- 1.3. Payment options include cheque or electronic funds transfer
- 1.4. Evzon reserves the right to alter prices without notification
- 1.5. All prices are shown in Australian Dollars including GST

2. Cancellation

- 2.1. All cancellations are to be received in writing
- 2.2. Cancellation of Goods or Services to be completed will be subject to a cancellation charge equal to 10% of the quotation, or the value of material and work completed to date on the cancelled project at the time of cancellation, whichever is greater

3. Design, printing and layout

- 3.1. A design of the invitation wording and layout will be forwarded to you via email
- 3.2. A spreadsheet template will be provided for your ordering details and a template for your final guest list, via email
- 3.3. Should errors be made by Evzon, we will reprint the invitation free of charge. However, if errors are made by you after final approval of proof or changes made after the approval and signing of your acceptance, additional costs will be incurred. Evzon does not take any responsibility should wording and layout be incorrect after your authorisation has been granted. It is your responsibility to make sure all wording, font selection and guest names and addresses (should this be the case) be correct. It is also your responsibility to ensure all spelling and names provided are correct
- 3.4. Considering the handmade nature of our product(s), there may be minor variations between items. Colours may vary as shown on screen to the real thing, so Evzon recommends you acquire a colour sample before placing your order

4. Delivery and postage

- 4.1. All orders are posted via Australia Post. Should Express Post (overnight delivery) be required it will be charged accordingly. Registered Post can be requested and will also be charged accordingly.
- 4.2. Delivery time is additional to the time required by Evzon to prepare your order so please take this into consideration. Evzon prefers to Express Post our products. However, please note that Evzon cannot be held responsible for loss/damage or delays caused by any third parties. Delivery charges are based on total weight of your order. The delivery fee will be additional and will be confirmed with you prior to despatch. Evzon ensure all orders are securely packed using packing boxes, bubble-wrap, filler etc, to ensure your order arrives in perfect condition.
